THE MILLION TREES NYC PROGRAM WAS LAUNCHED IN OCTOBER 2007 IN PARTNERSHIP WITH THE NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION WITH THE GOAL OF PLANTING 1 MILLION NEW TREES THROUGHOUT ALL FIVE BOROUGHES. THROUGH REFORESTATION ON PARKLAND, FREE TREE GIVAWAYS AND SCHOOLYARD PLANTINGS, NYRP PLANTS THOUSANDS OF TREES EACH YEAR, OFTEN IN ENVIRONMENTALLY UNDER-SERVED AREAS OF NEW YORK CITY. THIS PROGRAM BRINGS LOCAL GOVERNMENT, NON-PROFITS, NEIGHBORHOOD ORGANIZATIONS AND THOUSANDS OF INDIVIDUALS TOGETHER TO MAKE NEW YORK CITY A GREENER PLACE.

OUR ORGANIZATION WORKS WITH COMMUNITY LEADERS TO DESIGN THESE GARDENS IN A WAY THAT BEST SERVES THE LOCAL RESIDENTS, AS WELL AS TO PROVIDE FAMILY-FRIENDLY PROGRAMMING AND EVENTS.
